**TRANSPORTATION WAIVER**  
**FOR GRADUATION AT ROTHMAN CENTER**

**DECLINING / WAIVING Transportation Services**

I will be arranging for and providing transportation for my child to attend and participate in the graduation ceremony, (hereinafter referred to as "graduation"), scheduled to take place at the Rothman Center on the campus of Fairleigh Dickinson University, Hackensack NJ, (hereinafter referred to as the "Rothman Center")

I expressly agree to the following:

1. I understand that the students participating in graduation will be provided with transportation **TO and FROM** the Rothman Center. However, I have requested permission to arrange for and provide my own transportation, at my sole expense, for my child (named above) **TO and FROM** the Rothman Center.
2. I understand and agree that the Board, its officers, agents and employees are in no way responsible, nor does the Board assume liability, for any injuries or losses related to and/or resulting from my arranging for and providing private transportation for my child **TO and FROM** the Rothman Center for participation in graduation. As such, I am accepting full responsibility for any form of injury or property damage which may occur in connection therewith. I hereby release and hold harmless the Board, its officers, agents and employees from any liability whatsoever resulting from my choice to arrange for my child to be transported **TO and FROM** Rothman Center without being accompanied by the Board's employees.
3. I further understand and agree that it is my sole responsibility to ensure that my child arrives at the Rothman Center located at 140 University Plaza Drive Hackensack NJ at 5:00 p.m. on Thursday June 21, 2017 to meet the rest of the students participating in graduation. If, due to unforeseen circumstances, the graduation participants are unable to be present at the Rothman Center, I agree to assume and maintain full responsibility for my child, until the participants arrive, and release and hold harmless the Board, its officers, agents and employees from any liability whatsoever resulting from the same.
4. Upon arrival at the Rothman Center, I must personally ensure that my child checks in with the graduation chaperones to provide notice of his/her arrival. From that point forward, it is understood and agreed that my child will remain with the group, in accordance with the established itinerary and will not be permitted to participate in alternate activities and/or events. Although I may attempt to contact the graduation chaperones to arrange for an alternate meeting place consistent with the existing itinerary, I understand and agree that there is no guarantee that the graduation chaperones will be able to accommodate that request. Additionally, I understand and agree that the Board,

its officers, agents and employees, shall have no liability in the event that my child is injured or sustains property damage or loss prior to and/or while attempting to meet the group at the agreed upon, or any alternate, meeting location. I assume full responsibility for my child until such time as he/she arrives and checks in with a graduation chaperone.

5. I further understand and agree that my child's participation in graduation may be limited if he/she does not meet the group at the agreed upon meeting location. Moreover, in the event that my child does not meet up with the group in accordance with Paragraphs 4 and 5 above, he/she may not be permitted to participate in any activities and/or events. I agree to assume and maintain full responsibility for my child, including, but not limited to supervision, transportation, lodging and sustenance, and release and hold harmless the Board, its officers, agents and employees from any liability whatsoever resulting from or relating to the same.

**I hereby indemnify, release and forever hold harmless the Tenafly Board of Education, its officers, agents and employees from any and all liability, loss, damages, claims, or actions (including costs and attorneys' fees) that may arise out of and in connection with my child's participation in the Tenafly High School 2017 Graduation Ceremony scheduled to take place in Hackensack NJ on June 21, 2017, including, but not limited to my decision to arrange for and provide transportation to my child *TO and FROM* the Rothman Center. I further release the Board from financial obligations incurred by me (or my child) and agree to indemnify the Board with regard to such liabilities that may arise in connection my decision to arrange and provide transportation for my child *TO and FROM* the Rothman Center.**
